Article 1 Subject

1.1. The subject of the contract shall be the supply and installation of software and staff training in Syria for Lot 3, Financial Managemeth System: This lot is for the development and implementation of a set of fully functioning computer based financial management information systems for Budget Preparation, Budget Execution and Monitoring, Cash Management and Accounting (including Payroll Accounting), Personnel Post/Position Management and Property Management for six municipalities (Damascus, Homs, Tartous, Lattakia, Aleppo and Deir Ezzour), starting with the municipalities of Homs and Lattakia as pilots.

The place of acceptance of the supplies shall be the Municipalities of Syrian cities of Aleppo, Homs, Tartus, Lattakia and Deir Ezzor and the Ministry of Local Administration and Environment; the time limits for delivery shall be 12 months and the Incoterm applicable shall be DDP¹. The implementation period shall run from July 2007 to date June 2008.

1.2 The Contractor shall comply strictly with the terms of the Special Conditions and the technical annex.

Article 2 Origin

The supplies must originate in one or more of the of the 27 Member States of the European Units and the beneficiary countries of the MEDA Programme (Algeria, Egypt, Gaza and West Barney Israel, Jordan, Lebanon, Morocco, Syria, Tunisia and Turkey), the three countries of the European Liechtestein and Norway) and the candidates countries (Croate and Format

A certificate of origin for the supplies must be provided by the Contractor at the latest when he requests provisional acceptance of the supplies. Failure to comply with this condition may result in the termination of the contract.

The origin of the goods shall be determined according to the Community Customs Code or the international agreements to which the country concerned is a signatory.

Article 3 Price

- **3.1** The price of the supplies shall be that shown on the financial offer (specimen in Annex IV). The total maximum contract price shall be in euros 45,125.00.
- **3.2** The price referred to in Article 3.1 above shall be the sole remuneration owed by the Contracting Authority to the Contractor under the contract. It shall be firm and shall not be subject to revision.
- **3.3** Payments shall be made in accordance with the General and/or Special Conditions (Articles 26 to 28).

Article 4 Order of precedence of contract documents

The contract is made up of the following documents, in order of precedence:

- the contract agreement;
- the Special Conditions
- the General Conditions (Annex I);
- the Technical Specifications (Annex II);
- the Technical Offer (Annex III [including clarifications from the tenderer provided during tender evaluation];
- the budget breakdown (Annex IV);
- Specified Forms: Financial Identification Form (FIF), Legal Entity File (LEF), Performance Guarantee and Pre-financing Guarantee (Annex V).

The various documents making up the contract shall be deemed to be mutually explanatory; in cases of ambiguity or divergence, they should be read in the order in which they appear above.
